Members of City Council:

**Re: City Council must not bar and censor public demonstrations**

On November 28, 2017, the Executive Committee of Toronto City Council will consider Councillor James Pasternak’s request that the City prohibit what he calls “hate-sponsored” public demonstrations taking place on city or provincial property.<sup>1</sup>

Mr. Pasternak’s proposal would impose prior restraint on unknown expression that has yet to be made, on the basis of assumed emotional motives of demonstrators, and reactions of participants and observers. The contemplated prohibition is a violation of democratic values and would strip individuals of their fundamental human rights of freedom of expression and freedom of association. It is unconstitutional, and a violation of the *International Covenant on Civil and Political Rights*, which Canada has ratified.

The government must never be an agent of pre-emptive censorship by physical force.

Furthermore, it is not illegal to feel or express “hate”. By prohibiting the expression of any human emotion and by barring demonstrations, the State deprives society of essential information about inter-group and inter-individual conflicts that exist within the society. Free expression and interaction between groups with opposing views is required for a multicultural and democratic society to flourish and adapt to always changing circumstances, and must be allowed on open public venues.

The government must not — here, on the basis of projected or inferred beliefs and motives of others — label groups at large as “fascist”, “communist”, “anti-Semitic”, “Islamophobic”, etc., in order to pre-emptively bar demonstrations by physical force or civil-liability coercion. Doing so is unacceptable and repugnant fundamentally to the same degree as government suppression of rights on the basis of gender, race or religion. It would be an egregious police-state-like violation of universal principles.


Governments must guard from using expressed or inferred positions, opinions, and beliefs in the same way that in the recent past Western governments including Canada have used race and religion to strip citizens of their fundamental rights.

Lawmakers must consistently and duly reject using the bogeyman of “hate” as a pretext to suppress the constitutional rights of citizens, which has become too common a knee-jerk reaction in devising ways to censor expression that one finds distasteful or emotionally threatening.

Canada’s *Criminal Code* already has provisions that amply and constitutionally deal with crimes involving occurrences and threats of actual harm to specific actual persons.

We ask that you deny Mr. Pasternak’s censorship proposal and close that door. We ask that you uphold and reaffirm the rights of all individuals and groups to engage in demonstrations on public property.
