Re: CPSO's investigation and public statement about Dr. Kulvinder Gill's tweets on COVID-19 are harmful to the Ontario public

Dr. Copps:

The Ontario Civil Liberties Association (OCLA) is aware that one or more complaints have been submitted to the College of Physicians and Surgeons of Ontario (CPSO) regarding tweets made by Dr. Kulvinder Gill, a medical doctor practicing in Ontario. This was reported yesterday by the CBC.¹

In particular, a complaint was submitted on August 6, 2020 by Dr. Alexander Nataros of British Columbia. Dr. Nataros has provided the OCLA with his complaint, which is attached.

Yesterday's CBC article quotes the following response from the CPSO:

"It's important that physicians recognize the influence they may have on social media, particularly when it comes to public health. The CPSO believes questioning the value of vaccinations or countering public health best practices during COVID-19 represents a risk to the public and is not acceptable behaviour," wrote a spokesperson for the CPSO.

"Physicians who are found to be spreading misleading medical information that may bring harm towards patients can face practice restrictions or suspension for their actions."

This is an astonishing statement by the CPSO that imposes a chill on the freedom of speech of medical doctors in Ontario. If doctors may not publicly "question the value of vaccinations" or "counter [in their publicly-stated opinions] public health best

practices during COVID-19” then they are stripped of their ability – and indeed their responsibility – to independently evaluate whether the prevailing health practices serve the best interests of their patients, and the public is deprived of the authentic opinions of medical professionals.

This attack by the CPSO on the free speech and professional responsibility of medical doctors is occurring in a context where:


- We are experiencing sweeping draconian public health measures that are unprecedented in modern times,²
- The winter burden of all-cause deaths in 2020 in many Western countries is in line with its value in past years,³ and
- Compensation payments for vaccine injuries amount to hundreds of millions of dollars per year in the United States alone.⁴

Rash actions in times of perceived crisis can lead to disastrous consequences. This is why we must, as a society, consider a diversity of competing views and democratically decide the best course of action.

The CPSO is harming the public by making a direct attack on the pursuit of truth regarding public health in relation to COVID-19, through its public statement quoted above and its decision to investigate Dr. Gill’s tweets.

We ask that you immediately dismiss the investigation into Dr. Gill’s tweets and issue a public statement confirming you have done so and affirming the authentic freedom of expression of all Ontario medical doctors.
