Dear Attorney General Mulroney:

## Re: Criminal Code censorship prosecutions in Ontario

The Ontario Civil Liberties Association (OCLA) is in receipt of your letter dated August 16, 2018,<sup>1</sup> which was in response to our letter dated July 24, 2018.<sup>2</sup>

In our letter, we asked you to recognize that several *Criminal Code* provisions inherently violate human and natural justice rights, and violate the *International Covenant on Civil and Political Rights* in particular.

Your answer is that you will apply these unconstitutional provisions responsibly. You also refused to withdraw the Attorney General's consent for existing charges.

The problem is that any application of the said provisions necessarily violates fundamental rights, as we explained.

Any use or condoning of laws that inherently violate fundamental rights deteriorates our values and institutions, no matter how noble the motivating intentions.

We respectfully ask you to reconsider your position. Please do not apply these laws and please withdraw your consent for the on-going prosecutions.
