Thanks for writing Joseph. I agree with you and do not support this direction. I just don't think passing a bylaw will be enforceable unless we spend more dollars hiring enforcement officers, money that I would rather spend on direct public health supports. Ontario's medical officer of health and the region's medical officer of health do not recommend mandatory use of masks since the evidence is not clear that such use limits community spread. I would much rather emphasize social distancing and hand washing than passing a bylaw that can't be enforced and causing disharmony and conflict in the community over wearing a mask. It would make far more sense for the province to mandate this than local governments.

I also see your point about infringing upon civil liberties and really do wonder if my colleagues would be so quick to rush this in if we did not currently have a declared state of emergency. This issue and several others have been rushed through without due process under the cover of COVID and is causing me great concern.
